**FIRST AMENDMENT TO AMENDED AND RESTATED *
DECLARATION OF COVENANTS,
CONDITIONS AND RESTRICTIONS FOR
ABBOTTSFORD**

THIS FIRST AMENDMENT TO THE AMENDED AND RESTATED DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS FOR ABBOTTSFORD (the "Declaration") is made by the Abbotsford Homeowners Association, Inc. (the "Association") and certain Owners as defined in the Declaration.

WITNESSETH:

WHEREAS, the Declaration is of record in Book 8106, page 1, Register's Office for Davidson County, Tennessee; and

WHEREAS, Article XII, Section Two, provides that the Declaration may be amended by an agreement signed by at least two-thirds (2/3) of the Owners whose Sites are then subject thereto; and

WHEREAS, the Association and certain Owners desire to amend the Declaration as set forth below; and

WHEREAS, at least two-thirds (2/3) of the Owners consent to this First Amendment, in writing, the evidence of which is attached hereto.

NOW, THEREFORE, by these presents, the Association and at least two-thirds (2/3) of the Owners hereby amend the Declaration by adding Section Twelve to Article VI:

Section Twelve. Construction Deposits. The Board of Directors, in conjunction with the submission of plans for construction, reconstruction, remodeling, alterations or additions to any structure, building, fence, wall, driveway, path or other improvement of any nature upon a Site (the "Construction Plans") which is subject to this Declaration is empowered to require a deposit of a bond or cash deposit (the "Construction Deposit") in an amount determined reasonable by the Board of Directors, in its sole discretion, prior to the Construction Plans being reviewed for approval or disapproval. The Construction Deposit is in addition to the fee imposed by the Association for the review of such construction plans. The Construction Deposit is to provide security to the Association for

repair of any damage to the Common Area improvements caused by the Site Owner or contractor or subcontractors during construction. The initial Construction Deposit shall be established in the amount of Ten Thousand and No/100 (\$10,000.00) Dollars of which Two Thousand and No/100 (\$2,000.00) Dollars will be non-refundable (the "Non-refundable Portion"). The amount of the Construction Deposit and Non-refundable Portion may be changed, from time to time, as deemed appropriate by the Board of Directors.

THIS AMENDMENT shall become effective as of the date of recording in the Register's Office for Davidson County, Tennessee.
