**AMENDMENT TO BYLAWS FOR  
ABBOTTSFORD HOMEOWNERS ASSOCIATION, INC.**

This Amendment to Bylaws for Abbotsford Homeowners Association, Inc. the "Amendment") is made this 9<sup>th</sup> day of December, 2013, by Abbotsford Homeowners Association, Inc. (the "Association").

**WITNESSETH:**

WHEREAS, the Association is the duly formed governing body for that certain residential real estate subdivision located in Nashville, Davidson County, Tennessee known as Abbotsford;

WHEREAS, the Association desires to amend its Bylaws regarding eligibility for service on the Association's Board of Directors;

WHEREAS, pursuant to Section 8.07 of the Bylaws and Article XII, Section 2 of the Declaration, the Bylaws may be amended by an agreement signed by at least two-thirds (2/3) of the owners whose Sites (as that term is defined in the Declaration) are then subject to the Declaration; and

WHEREAS, this amendment has been signed by at least two-thirds (2/3) of the owners of Sites subject to the Declaration.

NOW, THEREFORE, for and in consideration of these premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Association, being empowered so to do, hereby amends the Bylaws as follows:

1. Amendment.

The first sentence of Section 5.02 of the Bylaws is hereby deleted in its entirety and replaced with the following:

*The Board of Directors shall consist of five (5) Directors, each of whom shall be a member of the Association in good standing, the spouse or life-partner of a member in good standing who resides with the member within Abbotsford, a beneficiary of a trust in good standing which owns a Site (so long as such beneficiary resides within Abbotsford) or a person residing within Abbotsford who has legal control of a legal entity in good standing which owns a Site.*

2. Ratification. In all other respects, the terms and conditions of the By-Laws are ratified and confirmed.
