# AMENDMENT TO AMENDED AND RESTATED DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR ABBOTTSFORD

This Amendment to Amended and Restated Declaration of Covenants, Conditions and Restrictions for Abbottsford (the "Amendment") is made this 9<sup>th</sup> day of December, 2013, by Abbottsford Homeowners Association, Inc. (the "Association").

# WITNESSETH:

WHEREAS, certain property was previously submitted to the Amended and Restated Declaration of Covenants, Conditions and Restrictions for Abbottsford of record in Book 8106, page 1, Register's Office for Davidson County, Tennessee (the "Declaration");

WHEREAS, the Association desires to amend the Declaration to restrict the placement of real estate signs within the Properties;

WHEREAS, pursuant to Article XII, Section 2 of the Declaration, the Declaration may be amended by an agreement signed by at least two-thirds (2/3) of the owners whose Sites (as that term is defined in the Declaration) are then subject to the Declaration; and

WHEREAS, this amendment has been signed by at least two-thirds (2/3) of the owners of Sites subject to the Declaration.

NOW, THEREFORE, for and in consideration of these premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Association, being empowered so to do, hereby amends the Declaration as follows:

1. <u>Amendment</u>.

Article VIII Section 2 paragraph 4. of the Declaration is hereby deleted in its entirety and replaced with the following:

Section 2. Signs Advertising Home Sales. In order to preserve and protect the decorum of the community, all signs relating to the sale or resale of homes within Abbottsford are prohibited on Abbott Martin Road, Vailwood Drive, at the entrance of Abbottsford or anywhere within the premises of Abbottsford, except that on days when an Owner is holding an "open house," signs advertising the open house with dimensions of two feet by four feet  $(2' \times 4')$  or smaller are permitted at the entrance and on the individual home site. Owners will also be permitted to post listings of Abbottsford homes for sale on the Abbottsford web site.

2. <u>Ratification</u>. In all other respects, the terms and conditions of the By-Laws are ratified and confirmed.
