AMENDMENT TO AMENDED AND RESTATED DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR ABBOTTSFORD

This Amendment to Amended and Restated Declaration of Covenants, Conditions and Restrictions for Abbottsford (the "Amendment") is made this 11th day of May, 2015, by Abbottsford Homeowners Association, Inc. (the "Association").

WITNESSETH:

WHEREAS, certain property was previously submitted to the Amended and Restated Declaration of Covenants, Conditions and Restrictions for Abbottsford of record in Book 8106, page 1, Register's Office for Davidson County, Tennessee (the "Declaration");

WHEREAS, the Association desires to amend the Declaration to prohibit leasing of Sites (as that term is defined in the Declaration) except in hardship situations as described herein;

WHEREAS, pursuant to Article XII, Section 2 of the Declaration, the Declaration may be amended by an agreement signed by at least two-thirds (2/3) of the owners whose Sites are then subject to the Declaration; and

WHEREAS, this amendment has been signed by at least two-thirds (2/3) of the owners of Sites subject to the Declaration.

NOW, THEREFORE, for and in consideration of these premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Association, being empowered so to do, hereby amends the Declaration as follows:

1. Amendment.

a. Article VIII of the Declaration is amended by deleting the title "Sale or Lease of Sites" and replacing it with "Leasing Prohibited; For Sale Signs Restricted."

b. Article VIII Section 1 of the Declaration is deleted in its entirety and replaced with the following:

***Section One.** Effective upon recordation of this Amendment with the Register's Office for Davidson County, Tennessee, rental or leasing of Sites is strictly prohibited; provided however, that all leases in effect on the date of recordation of this Amendment shall be unaffected hereby until the expiration of the current term of each such lease (or in the case of periodic tenancies, the expiration of the next period). Any inconsistency between this Amendment and any other provision of the Declaration not amended hereby (including without limitation references to "tenants," "leases," or other terms related to leasing) shall be resolved in favor of this Amendment. It is the intent of the Owners of Sites in Abbottsford that Sites be owner-occupied.*

Hardship Exceptions. To avoid undue hardships, the Association's Board of

Directors shall, upon written application, grant permission to an Owner to lease his or her Site if the Owner meets the criteria for one of the hardship leasing exceptions listed below. An Owner may lease his or her Site, on one (1) occasion only, for a period of not less than six (6) consecutive months and not more than twelve (12) consecutive months following:

1. Death of an Owner (rental to be allowed during probate period);
2. Confinement of an Owner to a medical or nursing care facility; or
3. Loss of job by an Owner or, if a Site is owned by more than one person, loss of job by at least one Owner.
4. An Owner may also lease his or her Site for any number of consecutive one-year terms (each term subject to the prior written approval of the Board) if Owner is a reservist in the United States Armed Forces who is called to temporary active duty, or is active-duty personnel in the United States Armed Forces who is temporarily deployed more than fifty (50) miles from the Site.

Prior to leasing any Site pursuant to one of the hardship exceptions stated above, Owner shall submit to the Board the name of the prospective tenant for the Board's approval or disapproval. The Board's determination of a prospective tenant's suitability shall be in the Board's absolute and sole discretion.

Leases permitted pursuant to a hardship exception listed above and approved by the Board are subject to the Association's Leasing Rules as they may be amended from time to time. Subleasing and assignment of leases is strictly prohibited.

If an Owner leases a Site in violation of this Section, in addition to any other remedy to which the Association is entitled, the Association may declare the lease to be terminated and commence eviction proceedings. In any such proceedings, the Association shall be entitled to recover from the leasing Owner and the tenant all expenses incurred by the Association, including without limitation the Association's reasonable attorney's fees. In addition, an Owner in violation of this Section shall be subject to reasonable fines in accordance with the Association's fine schedule.

The terms "lease" or "leasing" as used in this Section shall be construed expansively and shall include any arrangement (direct, indirect, written or unwritten) for the use or occupancy of a Site including without limitation a lease for any term, a tenancy at will, a tenancy at sufferance, a holdover tenancy, a lease/purchase contract and a lease with an option to purchase.

2. Ratification. In all other respects, the terms and conditions of the Declaration are ratified and confirmed.
