**AMENDMENT TO AMENDED AND RESTATED DECLARATION
OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR ABBOTTSFORD**

This Amendment to Amended and Restated Declaration of Covenants, Conditions and Restrictions for Abbottsford (the "Amendment") is made this 12th day of May, 2016, by Abbottsford Homeowners Association, Inc. (the "Association").

WITNESSETH:

WHEREAS, certain property was previously submitted to the Amended and Restated Declaration of Covenants, Conditions and Restrictions for Abbottsford of record in Book 8106, page 1, Register's Office for Davidson County, Tennessee (the "Declaration");

WHEREAS, the Association desires to amend the Declaration regarding responsibility for maintaining and repairing mailboxes;

WHEREAS, pursuant to Article XII, Section 2 of the Declaration, the Declaration may be amended by an agreement signed by at least two-thirds (2/3) of the owners whose Sites are then subject to the Declaration; and

WHEREAS, this amendment has been signed by at least two-thirds (2/3) of the owners of Sites subject to the Declaration.

NOW, THEREFORE, for and in consideration of these premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Association, being empowered so to do, hereby amends the Declaration as follows:

1. Amendment.

Article VI Section Two Paragraph 5 of the Declaration is hereby deleted in its entirety and replaced with the following:

5. (a) *Unless otherwise approved by the Association, swimming pools must be located to the rear of the main dwelling and shall be no nearer than five (5) feet to any Site line.*

(b) *Notwithstanding the provisions of Article VI Section 3 of this Declaration, in order to maintain uniformity of the appearance and location of mailboxes within Abbottsford, the Association shall be responsible for the maintenance, repair and replacement of all mailboxes, the cost of which shall be borne by the Association. The Association may move, remove and/or replace any existing mailbox if, in its sole discretion, the Board of Directors determines such action to be necessary or desirable.*

2. Ratification. In all other respects, the terms and conditions of the Declaration are ratified and confirmed.
